Authorize District Manager to Sign an Equipment Replacement Estimate from JWC Environmental for Muffin Monster Comminutor at the Main Lift Station:** District Manger informed the Board that the Muffin Monster is a grinder that chops and cuts large debris and wipes sent through our collection system. The Muffin Monster is at the Main Lift Station and our current one is at the end of its useful life. The new Muffin Monster will reduce the size of debris, so staff won't be called out to de-rag/clear debris that clog pumps. District staff will be able to install it in-house. Director Ryness made a motion to Authorize the District Manager to Sign an Equipment Replacement Estimate from JWC Environmental for Muffin Monster Comminutor at the Main Lift Station.
