Director Borkey questioned if having 25% of annual expenditures in the operating reserve is too high. District Manager explained that it is a requirement to have a minimum of 25% of annual expenditures in the operating reserves. Maybe need to open more accounts to keep track of funds and make sure we have all of that. There is a grammatical error on page 4 under Policy Goals in the last bullet point, should read “or” instead of “of”. Director Borkey made a motion to approve Burney Water District SB 1029-Compliant Debt Management Policy with corrections. Director Songer seconded the motion.

Found another one in Redding that is listed for \$40,000 and has all of the features we are looking for. Mike is going to go look at it. Still waiting to hear back about generator cost and heard from the Department of Financial Assistance that we should be able to receive funding to pay for the generator.
- Director Ryness directed District Manager Willie Rodriguez to have discussions with Chad from Sierra Pacific regarding the old well at Covanta. Investigate getting the water rights to take over the well and the possibilities of having a bottled water plant.
