Pool Manager's Report / Friends of the Pool Committee Report: Lola Harris Reported on behalf of Friends of the Pool that they paid \$800.00 to cover half of the cost of the Lifeguard and Water Safety Instructors Training. She also reported that the opening day party at the pool facility was stormy weather and had very low attendance but all of the kids that attended had a great time. The new tile wall they had put up has had some fading issues and they are working on fixing or installing a new one. Pool Manager Stephanie McQuade reported that the counts for their water fitness and lap swim programs have really picked up this year. Swim lessons started on June 12<sup>th</sup> and we will be having four sessions this year and so far all classes have good numbers. Had a very good inspection from Shasta County, all three pools had perfectly balanced chemicals and only had two things that needed to be fixed. The Burney Fire also came and did an inspection and would like to see some minor changes. Our last day for the season will be September 1<sup>st</sup> this year.

  - He has been spending a lot of time out at the Treatment Facility trying to dial in some process control while training our new OIT's so everyone is doing the same process and doing it efficiently.

- Having some issues with the online bill pay and are working to get those issues resolved so we can get it up and running.
- Have some staffing changes in the office and hired Debbie Jackson for summer help.
- Attended WRMS meeting the last couple of months and trying to make plans to replace some piping in the district.
- Our demand for water is up, we are pumping more than normal, so we should see that in the July-August time frame. Our water levels in the aquafer are up around 20 feet from October of last year.
- Been working with PACE Engineering to finalize the work for the Prop 1 Grant Project on the sewer side.
