Capita Grant of \$177,952.00. Those funds are for the Raymond Berry Community Pool, Washburn-Bue Park and the Civic Park. Some of those funds are going towards Master Planning for each site which will hopefully help us receive more grant funds in the upcoming Round 4. The maps that PACE put together for our Master Planning of each facility are located at the Burney Chamber of Commerce with fliers, community members are asked to pick up a flier and pick five things on each map that they would like to see at each facility. Also started having public input meetings with the Community via zoom.

Discuss Mandatory CSDA Board Trainings: District Manager Willie Rodriguez Discussed the Mandatory CSDA Board Trainings which include Public Service Ethics AB1234 scheduled for January 20th, 2020 from 10-12 and Sexual Harassment Prevention Training AB1825 scheduled for January 26th, 2020 from 10-12.

- **14. Director Reports / Committee Reports:** Director Ryness reported on the most recent CSDA Meeting. There is a new member on the Northern Network from the Quincy area and he will be taking over several regions along the Coast due to reorganizing the regions. He also attended his first LAFCO Meeting as an Alternative Commissioner.
- 15. Pool Manager's Report / Friends of the Pool Committee Report: Pool Manager Stephanie McQuade reported that the new slide just came in that was received through the McConnell Fund Grant.
- **16. District Manager's Report:** Willie reported on the following items:
 - An Employee has tested positive for COVID-19. The District has gone back onto a rotating schedule due to the counts going up in Shasta County. The positive employee was off on his rotation got the virus from a family member. All Employees have been very cautious and that employee will be out until January.
 - Have had several Parks meetings to get public input so we can submit our application for Prop 68 Per Capita Grant Round 4 Competitive Grants by the March deadline. They are favoring projects for expansion of existing Parks and New Parks.
 - Moving forward with the Microgrid Project located at the Well site and the Tesla Batteries for the Wastewater Treatment Plant. Should have these items on either the January or February Meeting to go over the Legal Documents.
 - Met with PACE Engineering for a walk through of the Wastewater Treatment Plant Improvements Project and do not believe that we will receive enough funds to complete everything. We are changing our scope of the project slightly to get as much done as possible; our goal is to create less sludge so we won't have to dispose as much.
- **Adjourn to Closed Session:** District Manager Willie Rodriguez reported that the District received a letter from our legal counsel dated December 7th, 2020 that they ruled in favor of the Water District and the Judge motioned to dismiss the lawsuit Sibert v Burney Water District due to late filing. Nothing new to report on item 18.
